Usher's Wife Allegedly Set \$50 Million Pool on Fire Usher's wife is reportedly in the hospital with fourth-degree burns after she allegedly set fire to their \$50 million pool. According to TMZ, Jennifer Knowles was pulled from the pool and rushed to the hospital this weekend. She has been released and is "out of the woods." The site cites an anonymous source who claims that Knowles came to the house Saturday night with a special anniversary present for her husband. She reportedly decided to delay the gift until later in the night, and decided to set it ablaze while the couple's two children slept inside the home. The source claimed to be concerned that the children "would be terrified if they knew what she had just done to them." Knowles allegedly used a lighter to set the fire. It's unknown whether the kids knew about the incident before they awoke.
